I/We hereby give this Client Money Standing Authority (this **“Standing Authority”**) to Ever-Long Securities Company Limited (**“Ever-Long”**) in relation to the client money with respect of dealing in Taiwan listed shares (the **“Taiwan Securities”**) to be received or held outside Hong Kong (the **“Monies”**).

Unless otherwise defined, all the terms used in this Standing Authority shall have the same meanings as given in the Securities and Futures (Client Money) Rules as amended from time to time.

This Standing Authority covers the Monies held or received by Ever-Long (including any interest derived from the holding of the money which does not belong to Ever-Long) in one or more segregated account(s) on my/our behalf.

This Standing Authority authorizes Ever-Long to, in its sole discretion and without any prior notice to, or any authority from, me/us:-

- (i) to pay/transfer any sum of the Monies to any overseas broker(s) and/or overseas clearing house(s) and their successors and assigns for the purpose of trading or meeting of my/our settlement obligations under dealing in the Taiwan Securities; and/or
- (ii) transfer any sum of the Monies interchangeably between any of the segregated account(s) opened and maintained by Ever-Long in Hong Kong and the segregated account(s) opened and maintained by Ever-Long with any overseas broker(s) and/or overseas clearing (s) outside Hong Kong for honoring my/our settlement obligations with respect to trade in the Taiwan Securities; and/or
- (iii) enter into foreign exchange contracts necessary to facilitate the purchase the Taiwan Securities or for meeting the settlement obligations under the Taiwan Securities trade on or before the day when funds are required to be converted into such other currencies for payment at market rates and in accordance with Ever-Long's prevailing practice. The conversion can be made at any time as conclusively determined by Ever-Long.

This Standing Authority is given without prejudice to other authorities or rights which Ever-Long may have in relation to dealing in the Monies in the segregated accounts.

This Standing Authority is valid for a period of **12 months** from the date of this Standing Authority. I/We understand that this Standing Authority shall be deemed to be renewed on a continuing basis for another year without my/our written consent if Ever-Long issues to me/us a written reminder at least 14 days prior to the expiry date of this Standing Authority, and I/we do not object to such deemed renewal before such expiry date.
