Part 1 Identification of Individual Account Holder 第1部 – 個人賬戶持有人的身分識辨資料

2. Hong Kong Identity Card or Passport Number 第2欄 香港身分證或護照號碼

Important Notes重要提示:

- ◆ **This is a self-certification form provided by an account holder to Ever-Long Securities Company Limited / Ever-Long Futures Limited / Ever-Long Capital Management Limited (the “Company” or “Ever-Long”) for the purpose of automatic exchange of financial account information.
